What information do we collect and how do we use it?

Depending on which part of the Salsation Fitness website you visit, we collect different types of information from and about you.

Information you provide:

By signing up for a Salsation Fitness Account, you will be providing us with personal information including your name, email address, phone number, city, and country.

If you are an instructor, you will be able to create an instructor profile which is visible to the public which includes your name and country. All other information will be displayed at your discretion. Please see your "Profile Information" page and consult the "Visible Online" column.

Information we receive about you:

Salsation Fitness uses session cookies to help personalise your online experience. Websites have no memories, without cookies a user can go from page to page and will be treated like a new visitor each time. These cookies remember your settings or items you purchased during that session to save you time. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer.

We use Google Analytics and/or other analytical programs to track your behavior online and gain statistical information at an aggregated level that may include browser type, device used, date/time stamps of access, user interests, location and more to adapt our content to better match your needs. Google uses cookies to achieve these results but the results are aggregated and individual users are not identified.

How do we use your information:

Salsation Fitness collects and uses your personal information to operate its website(s) and deliver the services you have requested. We do not sell, rent or lease our customer lists to third parties!

We may share data with trusted partners to help perform statistical analysis, send you emails, provide customer support, or arrange deliveries. All such third parties are prohibited from using your personal information except to provide these services to Salsation Fitness. They are required to maintain confidentiality of your information.

We keep track of websites and pages you visit within Salsation Fitness in order to determine which areas are most popular and analyse patterns of usage to make the website more useful.

We will only disclose your personal information, without notice, only if required to do so by law or in good faith believe that such action is necessary to:

1. conform to the rules of the law,
2. protect and defend the rights and/or property of Salsation Fitness
3. act under exigent circumstances to protect the personal safety of the users of Salsation Fitness website or in the public.

How can you access, update, or opt-out from this information?

All information you provide us can be accessed via your online Salsation Fitness Account. Please log in and update any information at any time.

You have the ability to accept or decline cookies. Most website browsers automatically accept cookies, however, you can change these settings in your browser. If you elect to decline cookies, please be aware that it will affect the performance of this website.

How do we protect this information?

We encrypt our information by using Secure Sockets Layers (SSL) protocols.

We restrict access of personal information to Salsation Fitness employees, contractors and agents who need to know what information in order to process it for us, and who are subject to strict contractual confidentiality obligations and may be disciplined or terminated if they fail to meet these obligations.

We review our information collection, storage, and processing practice regularly to guard against unauthorised access to the system.

Children under the age of eighteen

Salsation Fitness does not knowingly collect personal information from children under the age of eighteen. If you are under the age of eighteen, you must ask your parent or guardian for permission to use this website.
